

## VENDOR CONTRACT

1. Vendor will have their assigned vending area set up by 9:00AM and will complete tear down no later than 6:00PM.
2. NNDA is required to carry special event liability insurance coverage for the event. As a part of this coverage,
3. Exhibitors/vendors will receive passes, which must be carried at all times.
4. Limitation of Liability: NNDA assumes no responsibility for any property placed on the facilities by vendor and the NNDA is hereby relieved and discharged from any and all liability for any loss, injury or damage to persons or property that may be sustained by reason of the occupancy of the Nakai Hall under this agreement.
2. RESTRICTION ON EXHIBITS: The NNDA and its agent reserve the right to restrict as allowed by law the operation of any exhibit which may become objectionable to exhibitors or to the public.
3. NOISE: No sound amplification devices may be used by exhibitors without the prior written consent of NNDA. If NNDA approves the use of any such device, the exhibitor shall use the device in a manner that will cause the least disturbance. If NNDA determines that any device so approved is causing unnecessary noise the agent may revoke the approval of the device and require the vendor to remove the device.
4. Fire and Life Regulations: All exhibits must comply with Appropriate Fire and Life Safety regulations.
5. CANCELLATIONS / REFUNDS: If Vendor fails to pay the balance of space rental on or before 5:00 pm on Thursday, September 30th, the Vendor's rights to exhibit may be canceled without further notice or refund.
6. RIGHTS OF THE NNDA IN THE EVENT EXHIBITION IS NOT HELD: NNDA shall not be liable for any damages or expenses incurred by Vendors in the event the show is delayed, interrupted or not held as scheduled. , and if for any reason beyond the control of NNDA the conference is not held. NNDA may retain so much of the amount paid by Vendors as necessary to defray expenses already incurred by NNDA.
